1.	There is a \$125 enrollment fee due at the time of enrollment for new students.
2.	There is a \$100 registration fee for returning students.
3. 4.	The Academic and Program Fee of \$110 is due on September 30 th , or in two installments (Sept. 30 th & Jan. 31 st). Class Party fee of \$30 due October 15 th .
4. 5.	Tuition is due on the first of each month. There is a \$25 late fee for any payments received after the 10 th of the

6.	All financial accounts must be kept current. Delinquent accounts may result in student dismissal from school i not resolved. Parents will be responsible for returned check bank fees and any necessary legal fees incurred in the process of collecting past due balances.
7.	School Readiness payments must be made by the 15 th of each month. Delinquent accounts may result in studen dismissal and loss of School Readiness funding.
